



## TERMS & CONDITIONS

1. In order to book/register with VYOMA, the Troupe/Organization/individual must fill and submit the application form.
2. VYOMA can be booked/register for any art related activities (Play, Stand-up comedy, Workshop, Shoots, Dance, Music, Event, Classes)
3. Vyoma Artspace & Studio Theatre is not responsible for any copyright infringement on the part of the troupe.
4. The greenrooms and auditorium have to be vacated within 1 hr after the show or shoot, failing which a sum of Rs. 500 will be added every half hour thereon.
5. Use of Generators for any reason other than running the show will be charged extra.
6. If the entire show has to be run on generator to ensure uninterrupted supply, in spite of power being available, then additional charges towards running the generator would be applicable.
7. Bookings & Registrations are confirmed only on payment of full rental amount/Course Fee in cash, or on realization of the Cheque, or via online transfer. Please issue the cheque in the name of **YouAndMe LLP**.
8. All events must begin promptly at the designated time. All shoots, workshop, classes or other events should be held within the mentioned time only. Any extra time taken will be additionally charged (refer beginning of the document)
- 9.a.(EVENTS) In case of a cancellation 30 days or more before the show date, the troupe will be offered an alternative date for performance/Classes subject to availability in subsequent months not exceeding 3 months from the date of the first booking.
- 9.b. (EVENTS) In case of a cancellation within 30 days of the show date, the rental already paid shall be forfeited and only the deposit will be refunded. In case of a cancellation within 15 days of the show date, the rental already paid as well as the deposit will be forfeited.

10.a. (CLASSES) Fees paid to register for any curated courses/classes by VYOMA is non-refundable, non-cancellable and non-transferable to another person under any circumstances.

10.b. (CLASSES) For all courses that include the award of a Certification at the end of the course, 90% attendance for the course is mandatory. If attendance falls short, for any reason, the institute shall not award any promised Certification or recommendation at the end of the course and could be excluded from any final performances or evaluation specific to that course.

11. The copyright of the content, recorded audio, video and any material created and taught by the teachers, during my tenure at the institute is the property of the institute and the institute has all the rights to use such material at their discretion for marketing, branding and promotional purpose. No participants shall have claims on such material.

12. The booking cannot be transferred/ exchanged by any Troupe/ Organization unless agreed upon in writing by VYOMA.

13. Details of the event of the day must be shared with Vyoma Artspace completely. Failing to do so and departure from the promised show might result in extra charges for the troupe/organization, and/or cancellation of the event immediately.

14. The deposit is refundable only if no damages or material changes are made to the space that can incur expenses towards repair.

15. Any online booking events, the charges of online platforms have to be borne by the teams. Vyoma will not be involved in any such share or fees charged. If Vyoma books the event online, the charges will be borne entirely by Vyoma.

16. Consumption of alcohol and narcotics, drugs, smoking, chewing gum, chewing of pan-masala and such activities are strictly prohibited in studio. Anyone suspected of such a breach will be expelled from the program and reported to the law and order authorities.

17. Management shall not be held liable or responsible for any violation of intellectual property rights that may arise out of student or artists performance.

**In-case of any change to the program as announced by the management, due to external circumstances, (Govt/Non-Govt) the management shall not be responsible or answerable.**
